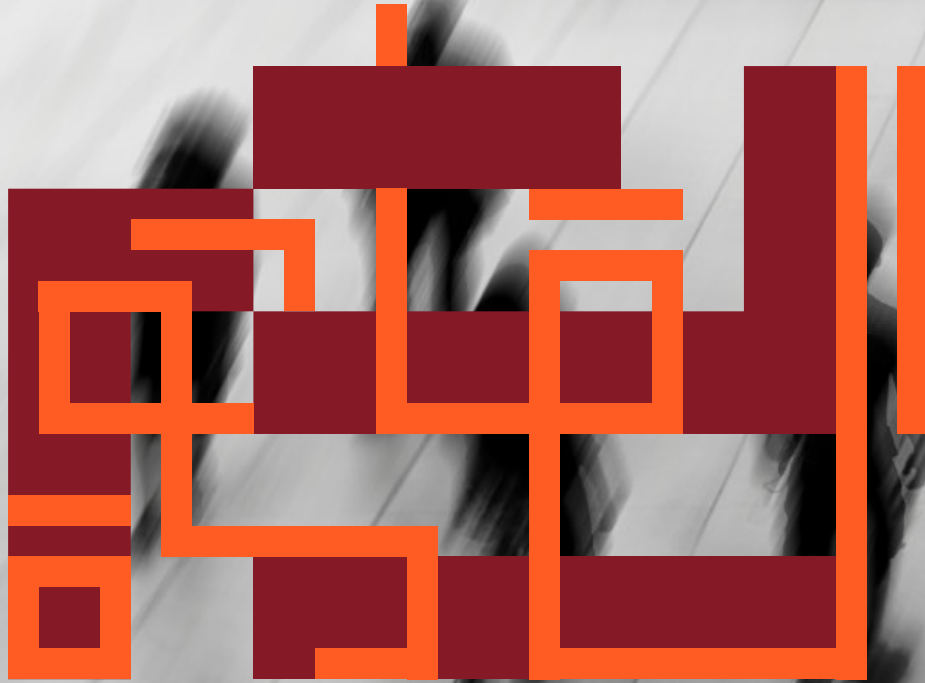

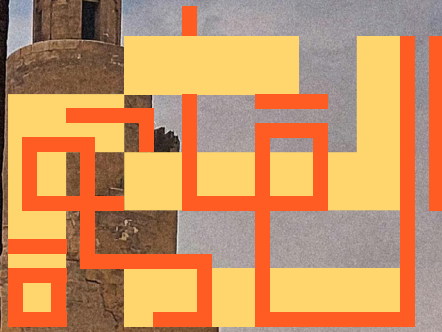

# EVENT HOSTING *GUIDELINES*

To ensure a smooth and organized event-hosting process for EAD '25, the following guidelines outline key information regarding event limits, topic proposals, inclusion fees, and submission deadlines.





# GUIDELINES

- To streamline the event hosting process and accommodate the high demand, the following guidelines have been established to support the smooth and organized preparation for EAD '25.
- The event will take place from 13 – 16 October 2025.
- Each participating firm will be permitted to hold up to a maximum of 2 events during EAD '25.
- Firms may partner together to co-host events. A co-hosted event shall be treated as a single event for each firm involved. Each co-host would therefore only be eligible to organise one other event (to reach the maximum of 2 per participating firm).
- Participating firms and institutions are free to propose topics relating to dispute resolution, commercial or investment arbitration and ADR before the submission deadline of 10 June 2025.
- The EAD '25 team reserves the right to propose changes to chosen topics in appropriate circumstances.



# INCLUSION FEE

- A fee of **USD 1000 (excluding VAT)** is payable for inclusion in the official schedule and on the EAD website. This fee helps support EAD '25 activities, including marketing, consulting, and the opening ceremony. Please note that this inclusion fee is separate from sponsorship packages.
- Subject to review, the Inclusion Fee may be waived for non-profit or charitable organizations, as well as young member groups.





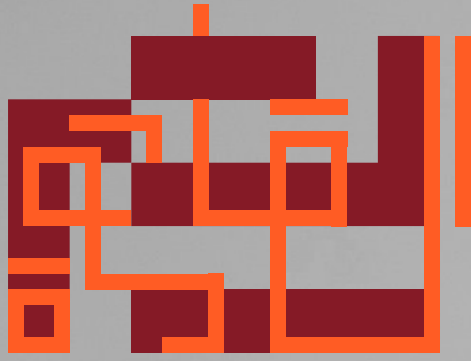
# DEADLINE
